CPAB Meeting Minutes, January 7th, 2015

The meeting was called to order at 6:15 with role call.

Members Present: Ashford, Bulls, Garvey, Gomez, Gulbransen, Haller, Johnson, Leonard, Link, Walton.

Members Absent: Castro, Webb.

1. Open Forum:

Josephine Lee from Beat 10x spoke and noted that she had a meeting scheduled with Area Commander Anthony Toribio in July that was postponed and she would like assistant getting it rescheduled.

2. OPD Stop Data analysis project: This item was rescheduled to March.

3. Ceasefire—Procedural Justice & Police Legitimacy:

Reygan Harmon, the Manager of the Cease Fire Program framed the conversation about Procedural Justice as aligned with the third goal of the Program of improving the relationship between the Police and Community. She provided background about the trainings that she observed in Chicago and how the department developed a unique training for OPD. She reported that over 400 officers had participated thus far with a 94% approval rating in this POST Certified Training. She introduced Lt.

Lerone Armstrong who is the Lead Trainer in the Program. Lt. Armstrong provided a framework for Procedural Justice Training that includes the components of fair treatment, giving a voice to people when they interact with law enforcement, explaining the process, and treating individuals with respect.

Member Garvey asked about the incorporation of Community Policing and Lt. Armstrong explained that one especially unique aspect to the Oakland training is the inclusion of a community member in the training which requires careful selection to strike a good balance between understanding community and police culture. He also explained that the NSCs had participated early in the trainings to provide feedback on the community component of the material. Ultimately he would like to take an abbreviated training to the NCPCs.

Member Bulls asked about the selection process for community members and Member Gulbransen asked about how the CPAB could support the process. Lt. Armstrong suggested the CPAB help get the message out about the training and that it would be coming to the NCPCs soon. Member Link noted that this is a great fit with both the Wasserman Recommendations and the NSA and would really help build trust in the community.

Chairperson Johnson requested that the CPAB receive quarterly updates and a schedule of when it would be received by the many NCPCs so that individual members of the CPAB could attend meetings in their respective districts.

There were five public speakers on this item:

Nancy Sidebothem advocated for OPD to involve OUSD in the trainings as well.



Paula Hawthorne, stated her support for the Cease Fire program and noted that an increase in trust in OPD equates to a decrease in violence in the community.

Assata Olugbala said that the Cease Fire program was dismantled in Chicago and that one challenge to its success was different communication styles between different races and she is concerned that any Oakland effort will only be successful if the department more closely reflects the community with more African American Oakland natives on the force.

Natalie Thomas (Beat 7x Co-Chair) noted that she lives near St. Andrew's Plaza, has relationships with many different people in her neighborhood, and only believes progress will come when people treat each other as equals and improve the lines of communication.

Marion Mills (from Beat 22x) stated that Cease Fire alone will not work and she would like more information disseminated to the community about the call-in process.

- **4.1:** NCPC Recertification of NCPCs reviewed at the October Meeting including 3Y, 9X, 10X, 12Y/13X, 13Y, 17XY, 22Y, AND 25X: Member Haller made a motion to approve, it was seconded by Member Walton and passed with 8 yeses and 2 abstentions.
- **4.2 NCPC Recertification of NCPCs reviewed at the November Meeting including 2X/5Y, 6X, 12X, 18XY/19, 25Y, 26XY, 30X, AND 35Y:** The Board had a brief conversation about process, Member Link noted in the past the entire Board received all of the recertification packets and Member Bulls aired concern about voting for something that he didn't review. Chairperson Johnson explained that there was a process and the Board agreed to have the NCPC Resource Committee review the bulk of the documents (before Members Bull and Link were seated on the Board).
- **5.1 Program Committee: E-Newsletter and Trifold Update:** Member Garvey reported that to keep the e-newsletter going required a minimal amount of funding that Joe DeVries offered to have the City Administrator's Office cover. He also provided a draft of the updated tri-fold that could be finalized and sent out (Attached).
- **5.2 NCPC Resource Committee Recertification/Review of Beats 2Y/5Y, 13Z, 16Y, 22X, 27X, 29X, 31YZ, 33/34X:** After Chairperson Johnson and Member Haller acknowledged that they had reviewed each individual submission, Member Gulbransen motioned to confirm all of the certification forms that were presented. The motion was seconded by Member Haller and passed with 7 yeses and 2 abstentions.

There were four public speakers on the item:

Nancy Sidebothem spoke in favor of the certification process noting that it was a way to provide some consistent standards among the NCPCs.

Rene Sykes, who has been an NSC since the beginning of the Community Policing Program thanked the Board for moving this process through to completion.

Natalie Thomas asked about creating a business card template for NCPC Officers to use that could be downloaded.

Ravinder Singh (Beat 22x Steering Committee) voiced concern over the process in that it was data rich but info poor. He had a lot of unanswered questions about who actually reviewed the certification packets and how the data would be used.



Chairperson Johnson indicated that the data will be used to inform him as he develops the Annual Report for the CPAB, Member Gulbransen supported this idea and suggested a "State of the NCPCs" report could be prepared and Member Gomez added his support for this as well.

- 6. Staff Report: Joe DeVries noted the current new additions to the Board, stated that there were still two definite vacancies; one for District 3 and one for District 6 and that he was waiting to hear back from OUSD regarding the status of their appointment.
- 7. Chair's Report: The Chair had nothing new to add.
- 8. Agenda Building: Member Gulbransen asked that the following items be placed on the February Agenda: Discussion of Documents such as the Annual Report, a Discussion about Elections, and a Discussion about Committees. Chairperson Johnson added that a Review of current Appointment Status of all Members was needed as some terms may have expired or are about to expire in March. Also, Chairperson Johnson added that he would like the group to consider asking for OPOA to attend an upcoming meeting and would like to have a discussion about Board Members visiting NCPCs and attending the Citizen's Police Academy.

The meeting adjourned at 8:15.

CPAB Draft Meeting Minutes February 4th, 2015

The meeting was called to order at 6:10 with roll call:

Members Present: Ashford, Bulls, Gomez, Gulbransen, Haller, Johnson, Leonard, Link, Walton, and Webb.

Members Absent: Garvey.

1. Open Forum:

Josephine Lee spoke in regard to Beat 10x and registered her concern that Joe DeVries, staff to the CPAB, not attempt to facilitate different factions within the Beat 10x NCPC.

Patrick McCullough also spoke and registered his support for the Beat 10x leadership. He suggested there are rules in place to be followed and that everyone involved should do so.

2. Board Introductions:

Chairperson Johnson asked that each member introduce themselves and speak briefly about their backgrounds so that everyone would have a greater perspective on each other.

Cathy Leonard: Native Oaklander, and Chair of the Santa Fe Community Association of Neighbors and the Vice Chair of the Beat 10Y NCPC. She is involved in a lot of neighborhood revitalization efforts.

Krista Gulbransen: has lived in Oakland for 24 years and is in non-profit executive management. She has been involved with the Maxwell Park NCPC for over ten years, started an event there known as "Day in the Park" in its tenth year.

Sal Gomez: Been on the Board for a year, was part of the Men's Golf Club for 22 years assisting with youth programs and also works with Council Member Gallo on a lot of weekend community cleanups.

Derrick Bulls: Been in Oakland since 1997, is the executive director of "Hands Helping Hands" as well as "Dignity Housing West" and serves on several State and County advisory boards regarding public safety, and on the City's Ad Hoc DAC Privacy Policy Committee.

Marcus Johnson: Transitioned to the CPAB from the Measure Y Oversight Committee in 2009, is the Chair of the Prescott NCPC and has been involved in their efforts for twenty years. He works with non-profit and for-profit developers and manages the 16th Street railroad station and partners with local non-profits who work with kids and people who need employment.

Sheryl Walton: Born and raised in Oakland, is a Public Health professional with a focus on community capacity building work in neighborhoods that need access to resources and economic development. She was on the Central City East Redevelopment Project Area Committee, is a member of the Block-By-Block Organizing Network, and is involved with a transitional housing program in Alameda County.



Jay Ashford: Lives in the hills of the Dimond District of Oakland and was appointed by the Mayor's office last year. He also served on the City's Budget Advisory Committee, and by day he works in the tech industry as an IT Project Manager.

Don Link: Has been connected to Community Policing since 1992 when the City first convened a task force to develop the program. He has chaired his NCPC since 1994 when it was created. And served on the CPAB from 1997 to 2007 and is glad to be back. He also noted the Board currently is more developed in the past and he is excited by this.

Renia Webb: Represents the Housing Authority, she volunteers in Oakland Schools and spends a lot of time supporting Oakland Parks and Rec programs and neighborhood clean-ups. She is an interior designer by training and is currently opening a new business.

Angie Haller: Represents the Neighborhood Watch Steering Committee, has chaired that committee for 4 years, and she has been an Oakland merchant for 35 years. She chaired her NCPC in the past and has successfully coordinated Home Safety/Security Trainings throughout the City in partnership with OPD.

3. NCPC Re-Certification: Current submissions reviewed

Re-Certification packets were reviewed and approved for Beats 24y, 16y, 32y, 35x, and 11x. There was discussion about sharing more of the pertinent data about NCPCs within a particular Members district to see that they are aware of any important issues. Joe DeVries suggested he could have an intern consolidate all the data from the many forms into one document.

4. NCPC 10x emails:

This item was pulled at the request of the sender of the letters. Member Leonard confirmed that she believes the group can work out their differences without having to come before the CPAB. Chairperson Johnson noted he also wants to see these sort of issues worked out first with their NSC or with a member of the CPAB Resource Committee before it were to come to the board. Questions were asked about whether the NCPC should have been re-certified and both Chairperson Johnson and Member Haller clarified that the issues raised were NOT issues that would prevent re-certification but instead were issues that the members should work out between themselves. Further, it was indicated that they are moving forward to do so.

Josephine Lee spoke on this item, she does not feel everything has been resolved but she believes there is friction between different groups in the area that have had historically different missions.

Joe DeVries noted that his duty as the staff to the Board is to share any information (emails, letters, etc.) he receives with the Chair of the Board; were he not to do so would be a breach of that duty. Member Leonard noted that it was she who told people to send their letters to Joe to see that the CPAB got them.

5. Continued Action Plan Initial Statement (PowerPoint attached)

Members Ashford and Walton reviewed the PowerPoint slide by slide and entertained clarifying questions. The Board showed broad support for the work and the definitions contained within the document as a way to really state clearly the role of the CPAB and what Community Policing means in Oakland.

Member Haller noted there are many things in the document that would be easy to understand if members go through the Citizens Police Academy. She also noted that the role of the problem solving officer and the SARA database isn't always clear to people.

Deputy Chief Cunningham spoke at this portion of the discussion about the fact that the Department is interested in making portions of the SARA Database available to the public (NCPCs) so that more people can have access to the info.

Member Bulls noted the "Tools and Tactics" binder could be a really effective resource to dust off and hand out. Member Gulbransen noted it needs to be modernized as it doesn't have much on electronic communication because it's so old.

This PowerPoint will be brought back to the Board.

- 6. Continued E-Newsletter and Tri-fold Update: This item was continued since Member Garvey was absent.
- 7. Members Report:

Each member discussed their recent activities as Board members within their districts. These included a variety of items including visiting NCPC Meetings, helping NCPCs with by-law development, participating in neighborhood clean-ups, house meetings, and events in their districts, assisting with outreach around burglary prevention, and focusing on blight in their community.

DC Cunningham introduced himself and explained a bit about his background, having been with the force since 1991. He was in Community Policing in the 1990's and fully supports the effort. He will serve as the OPD representative to the Board from here on out.

Allene Warren spoke on the importance of all sorts of outreach noting that her neighborhood uses NextDoor and Nixl, and they had 115 people at their last meeting.

- 8. This item was tabled.
- 9. Chair's Report:

Chairperson Johnson noted the items he handed out—the terms of each member as well as a list of what occurred over the year at the monthly meetings.

Joe DeVries announced that Chairperson Johnson and Member Haller participated on a panel discussion about police/community relations before a delegation of Norwegian Parliamentarians last month and di an impressive job. The meeting was adjourned at this point.

The meeting was adjourned at 8:30 and all other items were tabled to March.

COMPLAINT PROCESS

Oakland City Council Resolution No. 72727/79235, revised, Section 5.6 authorizes the CPAB to hear and

mediate disputes relating to a Neighborhood Council's compliance with Resolution 72727/79235 revised

C.M.S. The CPAB has established the follow process for complaints:

Complaints should be submitted to the Community Policing Advisory Board (CPAB).

II. The Chair of the CPAB determines whether the complaint falls under Ordinance 72727, if so, the

complaint is referred to the Resource Committee of the CPAB for investigation and hearing.

III. The Resource Committee is responsible for notifying the parties affected of the complaint.

Notification should include the Chair of the NCPC and the Neighborhood Service

Coordinator. The Neighborhood Service Coordinator is responsible for informing the

membership of the NCPC of the pending complaint.

IV. The Resource Committee shall schedule a hearing on the complaint where each party is given 15

minutes to address the issue.

V. The Resource Committee will make a determination on the complaint within 30 days and notify

the full CPAB and the affected parties.

VI. The full CPAB Board will vote to accept or reject the recommendation of the Resource

Committee.

VII. Either party may appeal the decision of the CPAB through the City Administrators office.

After receipt of the complaint, it will be reviewed by the appropriate CPAB (Resource Committee) and notification will be forwarded to the full CPAB Board. After any investigation, recommendations will be given as to any intervention or resolution.
