A. Request for Permission from Oaklandish Innovators Award Winners to Collect Money from Silent Auction and for Oaklandish to Collect Donations and Sell Oaklandish Apparel at the Radio Regata Event at the Lake Merritt Sailboat House on August 23, 2009: Gail McMillon read the staff report from the Oaklandish Innovators award winners to collect money from a silent auction and for Oaklandish to collect donations and sell Oaklandish apparel at their Radio Regatta event on Sunday, August 23, 2009. The money from the auctions would go to support the work of the organizations. The donations collected from Oaklandish would go towards recovering some of the money that went towards the Radio Regatta event.

B. Request for Permission for Tango Magdalena for a Fee Waiver to Host Open Dancing at the Lake Merritt Bandstand on Saturday, August 22, 2009, Saturday, September 22, 2009 and October 17, 2009: Staff received a request from Tango Magdalena for a fee waiver request to host open dancing at the Lake Merritt Bandstand on Saturday, August 22, 2009, Saturday, September 22, 2009 and October 17, 2009. Gail McMillon read the staff report and Jean Pierre Sighe answered questions from Commissioners. Commissioners were concerned that if they passed this request to waive fee's for a permit on the bandstand that this would be setting a precedence. At this time with all the cut backs in OPR it is not possible to waive the fees for the bandstand. The Commissioners did suggest that Tango Magdalena talk to OPR and see how they could partner with OPR at future OPR events to teach the tango.

MOTION: Commissioner Taylor entertained the motion to have Tango Magdalena enquire with OPR partner at future OPR events and not approve the fee waiver to host open dancing at the Lake Merritt Bandstand on Saturday, August 22, 2009 and October 17, 2009.
