Lily Kaplan from CIC answered questions and gave a brief background on Oakland's Feather River 85<sup>th</sup> year at Camps In Common. All funds received will be used as camperships for Oakland youth to enable them to attend programs at Oakland Feather River Camp (OFEC), in the summer of 2009. Last year CIC raised \$6,000 and were able to scholarship 15 children.
