**SUMMARY** 

Staff received a request from the San Francisco Mime Troupe, a non-profit organization, for permission to collect donations by passing a hat to attendees after the show at Lakeside Park on Wednesday and Thursday, September 11, 2008. They are also requesting to sell tee shirts and hats at the shows.

The collection of donations and proceeds from the sell of tee shirts and hats will help to cover half of their costs for the season.

FISCAL IMPACT

There will be no fiscal impact on the Office of Parks and Recreation.

BACKGROUND

The San Francisco Mime Troupe (SFMT) has held free theatre performances at Lakeside Park for at least 6 years, dating back to the 2002 inception of OPR's automated reservation system. The SFMT came before the PRAC last month requesting to sell t-shirts and hats and to pass a hat around to collect donations for their performances to be held at Mosswood Park in August. They were granted approval.

The SFMT has held free theatre performances at other Parks and Recreation sites such as Mosswood Park and Montclair Park in years past. Their events have been successful and went as planned.

The San Francisco Mime Troupe's mission is to reach the broadest audience on grass, in the sunshine, that addresses social issues of our time; race, war, health and environment.

RECOMMENDATION

Staff recommends that the Parks and Recreation Advisory Commission approve the San Francisco Mime Troupe's request for permission to collect donations and sell tee shirts and hats at the free theatre performances at Lakeside Park on Thursday, September 11, 2008, provided that all additional required permits are secured and received in the Office of Parks and Recreation's Central Reservations Unit.
