## 10. CONDITIONAL USE PERMITS:

• Request for Conditional Use Permits for Restroom Improvement Projects at the following three park restrooms: Sobrante Park, Hardy Park, and Cesar Chavez Park. Denise Louie of the City's Community and Economic Development Agency presented a report regarding projects to install restrooms in three Oakland parks. Commissioner Montauk was concerned with homeless sleeping in the restrooms, and the responsibility of cleaning the toilets. Commissioner Wong expressed concern about negotiating the lease with Alameda County Flood Control and wanted to know if the installation of the restrooms was conditional with the new signing of the lease.

MOTION to request for conditional use permits for restroom improvement projects at the following three (3) park restrooms: Sobrante Park, Hardy Park, Cesar Chavez Park.

#### 12. NEW BUSINESS:

A. Request to Rename Brookfield Park, Located at 525 Jones Ave, East Oakland to the Bill Patterson Park: The community led by Ruth Beckford, The NAACP and a host of friends are requesting to rename the Brookfield Community Center to Bill Patterson Community Center.

MOTION to rename Brookfield Park to the Bill Patterson Park

MOTION PASSED: 9- in favor; 1-abstention (Mohiuddin)

B. Request to allow dogs on lease in Mosswood Park in Pathways. OPR Staff presented a report detailing a request from the Mosswood area community and dog owners to change the City's ordinance regarding dogs in parks. The community requests that dogs be allowed on leash on park pathways in Mosswood Park to allow better access to the Dog Play Area. Five community members spoke in favor of allowing dogs on leash in Mosswood Park and about the benefits of having dogs and dog-owners in the park. Questions were raised regarding issues of cleanliness in general park use areas, dog waste disposal bags, and rules regarding limiting dogs to pathways. Commissioners were concerned about the precedent that supporting the amendment to the Ordinance would set. Commissioner Montauk suggested implementing a pilot program for six months to see how well the general park users and the dog owners are able to share the park. Commissioner Arcineaux expressed concern that other users of the parks will not want dogs there. He visited the site and spoke to park users who were not in favor of allowing Commissioner Arcineaux would like to make sure that all of the dogs in the park. community's voice is being heard. OPR's Director assured the Commissioners that the community's voice was heard at the onset of the development and funding of the dog park. Commissioner Taylor expressed concern about how the park would be monitored regarding non-compliant dog owners. All of the Commissioners agreed that proper signage was crucially important. The Commissioners would like to ensure that all the community is involved.

MOTION: Recommendation to amend the City's dog ordinance to allow dogs in all areas of the park as long as they are on six-foot leashes. Moved by: Richards;

Seconded by: None-MOTION: FAILED

MOTION: Recommendation to implement a six-month pilot program allowing dogs on-leash on designated pathways in Mosswood Park with adequate signage and cleanup amenities provided.

Moved by: Montauk; Seconded by Enabulele MOTION PASSED: 9 in favor; 1 – opposed (Arcineaux)

**Note:** In order for a pilot program to be implemented, the City's dog ordinance will have to be modified by city Council to make it lawful. OPR will prepare a staff report and forward the Commission's recommendations to City Council.

C. Request for the San Francisco Mime Troupe to Collect Donations and Sell Mime Troupe Merchandise in Lakeside Park on Thursday, September 11, 2008: Ed Holmes and Gail McMillon spoke for the San Francisco Mime Troupe requested to collect donations along with the sale of tee shirts and dry goods.

MOTION: To allow the San Francisco Mime Troupe to collect donations and sell merchandise at their event in Lakeside Park on September 11, 2008.
