Permission to Dedicate a Blossoming Tree Accompanying Memorial Plaque to be Placed at Lake Merritt Park for Lorain and Fred Philips who

lived in Oakland for 45 Years.

SUMMARY

The Office of Parks and Recreation (OPR) received a request from the Philips family to dedicate a blossoming tree to their Aunt and Uncle (Lorain and Fred Philips) who lived in Oakland for 45 years and enjoyed and loved the Lake Merritt area for its beauty. Lake Merritt provided them with many a lot of happy times and sweet memories.

The family would like to install a blossoming tree accompanying memorial plaque to be placed at Lake Merritt Park. The plaque would be made of a simple grey-tone granite plaque that would measure 13" x 9" high and 1" thick, polished on the front and sides. The plaque would be mounted with a stone back stand with threaded mounting pins for installation in concrete, as suggested by Jim Ryugo of PWA, who has agreed to oversee the project. The engraved inscription would read: "In Memory of Lorain and Fred Philips".

FISAL IMPACT

There will be no fiscal impact on the Office of Parks and Recreation. The tree, plaque and installation will be paid for by the Philips Family.

RECOMMENDATION

Staff recommends that the Parks and Recreation Advisory Commission approve the request to let the Philips family dedicate and install a blossoming tree to accompanying memorial plaque to be placed at Lake Merritt Park in dedication of their Aunt and Uncle, Lorain and Fred Philips.
