- A. Request for Permission from Skyline High School Class of 1974 Reunion to Collect Entrance Fees, Sell Drink Tickets for Alcoholic Beverages and Authorize the Standard Hourly Charges at Sequioa Lodge on Saturday, October 17, 2009: Staff received a request from the Skyline High Class of 1974 Reunion for permission to collect entrance fees at the door, sell drink tickets for alcoholic beverages, and authorize the standard hourly charges at Sequoia Lodge on Saturday, October 17, 2009. The money collected will be used to cover the event costs, including the room rental, catering, mailing, decorations, etc.
- B. Request for Permission for the Friends of deFremery Center to install Ramps, Billboard and Mural at The deFremery Park: Staff received a request from the Friends of deFremery Center and Town Park and San Francisco Museum of Modern Art to install a billboard, and a mural at deFremery Park.
- C. Request for Permission from the Philps Family would like to Dedicate a Blossoming Tree and Accompanying Memorial Plaque to be Placed at Lake Merritt Park: The Director received a request from the Philips family to dedicate a blossoming tree and accompanying plaque to be placed at Lake Merritt Park. The simple grey-tone granite plaque would measure 13" x 9" wide and a 1" thick polished on the front and sides of the plaque. The installation would be in concrete, as suggested by Jim Ryugo of PWA who has agreed to oversee this project. The engraved inscription would read: In Memory of Lorain and Fred Philips.
- D. Request for Permission from the San Francisco Mime Troupe (SFMT) to Collect Donations by Passing a Hat and Sell Event Related Merchandise at Lakeside Park on Thursday, August 6, 2009 and Mosswood Park on Saturday, August 29, 2009. The Funds Collected will Help Cover the Cost for the Season: Staff received a request from the San Francisco Mime Troupe (SFMT), a non-profit organization, requesting permission to collect donations by passing a hat and sell event related merchandise at Lakeside Park on Thursday, August 6, 2009 and Mosswood Park on Saturday, August 29, 2009. The money collected will help cover the cost for the season. This is the 50th year that the SFMT has performed in Bay Area parks with free theatrical performances. The SFMT has rented both Lakeside Park and Mosswood Park in the past. They came before the Parks and Recreation Advisory Commission in 2007 and 2008 for approval to collect donations and sell event related merchandise. The type of merchandise that will be available to purchase will be San Francisco Mime Troupe hats, shirts, recorded music, Frisbees, books, and bags.

Request for Permission from Jean Quan's Office to Fully Restore the Abbey a Non-Profit, City-owned Building and Provide Visitors with Educational Information About Joaquin Miller and The Park: Staff received a request from Councilmember Jean Quan's office to restore the Abbey which is a non-occupied, city-owned building built in 1886 by poet Joaquin Miller. The structure was partially restored in 2005. Since then, the members of the Joaquin Miller Park Working Group, representing park users and city representatives, have wanted to fully restore the structure to the way it looked in photos of the late 1800s and to provide visitors with educational information about Joaquin Miller and the park. The Abbey is a City of Oakland Landmark and it is also listed on the National Register of Historic Places.
