### **MINUTES**

#### 1. CALL TO ORDER:

A regular meeting of the Parks and Recreation Advisory Commission was held at the Lakeside Park Garden Center, 666 Bellevue Avenue, Oakland, California. Chairperson Webb convened the meeting at 4:48 p.m. Mary Perisic, Recording Secretary to the Commission, conducted roll call. A quorum was present.

MOTION: Commissioner Nelson moved approval. Commissioner Patterson seconded the motion which passed unanimously.

#### 7. **COMMUNICATIONS:**

Letter to Matthew Webb from Dr. Harry Edwards dated March 13, 2002: Regarding the OPR recommendation that PRAC meet once a month for the next six months, the Commission decided to propose that they begin meeting once monthly in May and resume meeting twice monthly in September. Commissioner Webb will be meeting with OPR Director Dr. Harry Edwards to discuss the issue.

Commissioner Abad requested that staff provide at the May meeting all the necessary information for the recreation center directors for summer program ramp up, including how the centers access funds for their summer program and the hiring of staff.

9. **ADVISORY COUNCIL REPORTS**: Commissioner Wong attended the Lincoln Square Advisory Council monthly meeting. The Advisory Council is very active and enthusiastic and is complying with the OPR policies on funding.

Commissioner Webb attended the City Stables Advisory Council. They are planning a rodeo for May 11 and all Commissioners are invited to attend. All rodeo activities will be humane. The City Stables' conditions are improving daily.

### 11. UNFINISHED BUSINESS:

A. Appeal of Tree Removal Permit ND01-218, 1814 East 23<sup>rd</sup> Street: Mr. Dan Gallagher, Tree Supervisor II, provided a brief history of the tree appeal for the removal of the two large redwood trees. Since the previous meeting the Tree Section did an evaluation of the trees, with the tree closest to the house valued at \$8,400 and the larger tree valued at \$9,700. He advised that the Commission can overturn the Tree Division's decision and allow the trees to be removed. He also suggested that they may decide to approve removal of the tree closest to the house. Ms. Lorynne Dupree', the property owner, had the trees inspected by an independent arborist who advised that root pruning would pose a risk of the trees falling. She did not have a copy of the arborist's report, but can provide it at a future date.

MOTION: Commissioner Fischbach-Benson moved to continue the item in thirty days. Commissioner Nelson seconded the motion which passed unanimously.

Further discussion ensued on the tree appeal process. There was discussion on whether or not staff and the appellant can resolve the issue themselves and decide to remove one tree only. Commissioners felt that this would not be a correct procedure, since the original permit for the removal of the two trees was denied, and since the Commission meeting of 2/27/02 was attended by two people who opposed the appeal.

MOTION: Commissioner Fischbach-Benson moved to reconsider her previous motion. Commissioner Abad seconded the motion which passed unanimously.

MOTION: Commissioner Fischbach-Benson moved to table the matter until staff and the property owner are ready to bring the item back. Commissioner Abad seconded the motion which passed unanimously.

#### 12. **NEW BUSINESS:**

A. Request to Rename Foothill Meadows Park in honor of César E. Chávez: Mr. Noel Gallo, Manager, Park Services, introduced the Oakland students who had formed an organization known as the Youth Advocates for Fruitvale Parks and Open Spaces. The students collected over 600 signatures and 30 letters in support of the renaming. With the support of the Unity Council, they have also helped to reclaim Foothill Meadows Park. OPR staff supports their request to rename Foothill Meadows Park in honor of César E. Chávez.

The following speakers supported the name change: Cristina Lima, Minerra Perez, Lopez Rogelio, Agnes Ramirez-Grace, Jenny Kassan, Rosa Fuenas, Rita Torres- Gonzalez. Having the park renamed in honor of César E. Chávez will have a positive impact on the community and provide historical significance honoring one of the great American heroes. There were no speakers opposed to the name change.

The Commission commended the students for their efforts to organize the petition for the renaming of the park. They applauded the students for their hard work making a difference in the community.

# MOTION: Commissioner Wong moved approval. Commissioner Patterson seconded the motion which passed unanimously.

Role of PRAC in relation to Advisory Councils: Ms. Francine LarKrith-Thompson advised that PRAC could take a larger role in supervising and helping the advisory councils, since this was a role that former Commissioner Ray Bobbitt was actively involved in. Commissioner Wong stated that oversight of the advisory councils was the responsibility of staff and that PRAC became involved when it volunteered to helped staff with the re-writing of the Advisory Council Manual. Commissioner Abad felt that the Center Directors could support the advisory councils if they were given information and support from OPR administration. Commissioner Fishbach-Benson would like to see what other cities are doing to incorporate community support.
