7. CONSENT NEW BUSINESS:

- A. Request Approval on behalf of EastSide Arts Alliance to Collect Donations and to have Food and Non Food Vendors at their 14<sup>th</sup> Annual Malcolm X Jazz Festival on Saturday, May 17, 2014 in San Antonio Park. The Parks and Recreation Advisory Commission review the staff report for Item 7A presented by Gail McMillon. The EastSide Arts Alliance Director Elena Serrano requested permission from Oakland Parks and Recreation to collect donations and to have merchandise and food vendors at their 14<sup>th</sup>

Annual Malcolm X Jazz Festival scheduled to take place at San Antonio Park on Saturday, May 17, 2014. The funds collected will be used to cover the cost of producing the festival.

8. NEW BUSINESS:

- A. Request for Approval to Dedicate a Bench to Pamela. The Parks and Recreation Advisory Commission reviewed the staff report for Item 8A presented by Dana Riley. Ms. Joanne Fedeyko contacted the City requesting that a bench be dedicated to honor her co-worker and good friend Pamela Wright. The desired bench location is in front of the Edoff Memorial Band Stand in Lakeside Park. The specific bench faces the lake and is one of the new benches that ring the circle of grass. The plaque installation process is in accordance with the Public Works Agency construction requirements. Funds were posted to the Friends of Parks and Recreation for future maintenance and repairs.

Commissioner Selna arrived.

- B. INFORMATIONAL REPORT CONSIDERATION OF NAMING POLICY FOR PARKS, RENOVATING & BUILDING FACILITIES AND EXPANDING PROGRAMS FOR THE 21<sup>ST</sup> CENTURY. The Parks and Recreation Advisory Commission (PRAC) reviewed the informational staff report presented by Director Audree V. Jones-Taylor. The Oakland Parks and Recreation Department (OPR) requested that the (PRAC) consider amending the existing Naming Policy, to include the opportunity for corporations, and the philanthropic to make financial contributions towards the renovation and update of facilities, buildings, landscape areas, programs, and other related Park and Recreation assets, in return for naming rights for a designated time period to the City of Oakland.

OPR conducted a major fundraising campaign for the renovation to the Curt Flood Sports Complex. Businesses from corporate America were invited to participate in exchange for legacy naming rights. The City of Oakland's position on the subject has been not to sign over the naming rights of area ball fields. Without a set policy, OPR is losing funding opportunities necessary to facilitate costly upgrades, renovations, repairs and ongoing maintenance needed to maintain City assets in the department. A policy is also needed for

receiving in-kind donations. FOPR will work with OPR to solicit sponsorships and endowments on behalf of the City of Oakland and work from a list of priority programs and facilities.

OPR is firm in its position that privatization of City of Oakland Parks and Recreation assets is not its goal for seeking a set policy for naming rights. In addition, it is imperative to be cautious of the acceptance of gifts and contributions that are not aligned with the spirit of the department, names with connotations that by contemporary community standards are derogatory or offensive will not be considered. The naming rights policy issue will be open for public input and presented to City Council.

After introductions by Director Jones-Taylor, (FOPR) Board President Barry Weiss made a brief presentation on the Naming Policy.

Barry Weiss informed the Commission that the demand for use of parks and park facilities are raising and funding for maintenance is receding. To address the issue, policies for corporate and the private sector are needed. Legacy Naming has surpassed estate giving and grants. Legacy naming should not be changed, but can be, e.g., Curt Flood Complex Presented by (name of corporation or funder).

City Council and the PRAC would approve the naming policy which should meet contemporary standards and which protect the City while seeking funding. Commemorative names would not be changed. Several cities that have used this model were cited. They including: San Carlos, Modesto, Windsor, Pigeon Forge, TN, Pittsburg, PA and Miamisburg, OH. Mr. Weiss indicated that he would like to sit on the Naming Policy Committee.

**Commission Comments:**

Monies received will be kept separate from the General Purpose Fund or OPR's baseline.

OPR's objective is to renovate, upgrade and increase the maintenance of its current ball fields and facilities, not to acquire more.

The Naming Rights Committee will review the City's current policies and will meet before the next PRAC meeting.

Distinctions should be made between commemorative donors and company or corporations seeking recognition for their contributions. Rules need to be established for each group.

Naming approval should remain within the Park and Recreation Advisory Commission.

The Parks and Recreation Advisory Commission reviewed the staff report for Item 8C presented by Donte' Watson. MacDaddy of Oakland (Quebradita) Dance group, a local cultural dance

organization, submitted a request to Oakland Parks and Recreation, Ira Jinkins Recreation Center to collect participant and entry fees at their, April 26, 2014 Dance Competition to be held at Ira Jinkins Recreation Center. The fees collected go toward coverage of the various costs associated with putting on the event (i.e. facility rental, DJ, video coverage of event, security, purchase of trophies etc.).




